

Rule 16. Discovery.

(a) Except as otherwise provided, the prosecutor shall disclose to the defense upon request the following material or information of which he has knowledge:

- (1) relevant written or recorded statements of the defendant or codefendants;
- (2) the criminal record of the defendant;
- (3) physical evidence seized from the defendant or codefendant;
- (4) evidence known to the prosecutor that tends to negate the guilt of the accused, mitigate the guilt of the defendant, or mitigate the degree of the offense for reduced punishment; and
- (5) any other item of evidence which the court determines on good cause shown should be made available to the defendant in order for the defendant to adequately prepare his defense.

(b) The prosecutor shall make all disclosures as soon as practicable following the filing of charges and before the defendant is required to plead. The prosecutor has a continuing duty to make disclosure.

(c) Except as otherwise provided or as privileged, the defense shall disclose to the prosecutor such information as required by statute relating to alibi or insanity and any other item of evidence which the court determines on good cause shown should be made available to the prosecutor in order for the prosecutor to adequately prepare his case.

(d) Unless otherwise provided, the defense attorney shall make all disclosures at least ten days before trial or as soon as practicable. He has a continuing duty to make disclosure.

(e) When convenience reasonably requires, the prosecutor or defense may make disclosure by notifying the opposing party that material and information may be inspected, tested or copied at specified reasonable times and places. The prosecutor or defense may impose reasonable limitations on the further dissemination of sensitive information otherwise subject to discovery to prevent improper use of the information or to protect victims and witnesses from harassment, abuse, or undue invasion of privacy, including limitations on the further dissemination of videotaped interviews, photographs, or psychological or medical reports.

(f) Upon a sufficient showing the court may at any time order that discovery or inspection be denied, restricted, or deferred, that limitations on the further dissemination of discovery be modified or make such other order as is appropriate. Upon motion by a party, the court may permit the party to make such showing, in whole or in part, in the form of a written statement to be inspected by the judge alone. If the court enters an order granting relief following such an ex parte showing, the entire text of the party's statement shall be sealed and preserved in the records of the court to be made available to the appellate court in the event of an appeal.

(g) If at any time during the course of the proceedings it is brought to the attention of the court that a party has failed to comply with this rule, the court may order such party to permit the discovery or inspection, grant a continuance, or prohibit the party from introducing evidence not disclosed, or it may enter such other order as it deems just under the circumstances.

(h) Subject to constitutional limitations, the accused may be required to:

- (1) appear in a lineup;
- (2) speak for identification;
- (3) submit to fingerprinting or the making of other bodily impressions;
- (4) pose for photographs not involving reenactment of the crime;
- (5) try on articles of clothing or other items of disguise;

(6) permit the taking of samples of blood, hair, fingernail scrapings, and other bodily materials which can be obtained without unreasonable intrusion;

(7) provide specimens of handwriting;

(8) submit to reasonable physical or medical inspection of his body; and

(9) cut hair or allow hair to grow to approximate appearance at the time of the alleged offense. Whenever the personal appearance of the accused is required for the foregoing purposes, reasonable notice of the time and place of such appearance shall be given to the accused and his counsel. Failure of the accused to appear or to comply with the requirements of this rule, unless relieved by order of the court, without reasonable excuse shall be grounds for revocation of pre-trial release, may be offered as evidence in the prosecutor's case in chief for consideration along with other evidence concerning the guilt of the accused and shall be subject to such further sanctions as the court should deem appropriate.

77-38-6. Victim's right to privacy.

- (1) The victim of a crime has the right, at any court proceeding, including any juvenile court proceeding, not to testify regarding the victim's address, telephone number, place of employment, or other locating information unless the victim specifically consents or the court orders disclosure on finding that a compelling need exists to disclose the information. A court proceeding on whether to order disclosure shall be in camera.
- (2) A defendant may not compel any witness to a crime, at any court proceeding, including any juvenile court proceeding, to testify regarding the witness's address, telephone number, place of employment, or other locating information unless the witness specifically consents or the court orders disclosure on finding that a compelling need for the information exists. A court proceeding on whether to order disclosure shall be in camera.







SYNOPSIS

The suspect in this case was found to be in possession of methamphetamine and drug paraphernalia after he was searched incident to arrest while being taken into custody for a warrant.

NARRATIVE

On 04-27-15 at approximately 2303 hrs, I observed a green Honda Civic, CA Listing [REDACTED], traveling southbound in the 2700 block of Grant Ave. The light was red at the 28th Street / Grant Ave intersection. As the vehicle turned westbound onto 28th Street it failed to stop prior to the stop line. I stopped the vehicle in the 100 block of 28th Street.

I made contact with the driver, later identified as Kimberlee Angerson, and I asked her for the driver's license, vehicle registration, and insurance information. Kimberlee could not immediately produce this information. As Kimberlee was looking for the information, I asked her passenger if he would mind telling me his name. The man identified himself as Steve Orvis. Kimberlee then provided me with what documents she could find. I ran the information along with Steve Orvis' name and discovered that Steve had a warrant for his arrest. I returned to the vehicle and arrested Steve for his warrant. Search incident to arrest I found a 3" glass pipe with a burnt bulb on one end in Steve's front pants pocket. Based on my training and experience I know this type of pipe to be commonly used to smoke methamphetamine. In Steve's front right coin pocket I found a small clear plastic baggy with an off white crystal substance. This substance had the texture and appearance of methamphetamine. I later NIK tested this substance and it flashed positive as an Amphetamine. In Steve's lower left pant leg I found a 8" x 4" black pouch containing a clear plastic baggy with a white crystal substance that had the appearance and texture of methamphetamine. There was also a clear plastic baggy containing many other clear baggies, and a gray digital scale. I advised Steve of his

rights per Miranda. Steve said he understood his rights and he agreed to speak with me. I asked Steve about the items I found on his person. Steve said obviously all of those things are his. Steve said Kimberlee had no idea they were inside the vehicle. I asked Steve about the multiple baggies and the digital scale. Steve said they were for his personal use and to make sure he got his stuff right. I asked Steve if we would find anything else in the vehicle, and he said we wouldn't. Steve said the black backpack in the back passenger seat of the vehicle was his.

Believing there may be more illegal narcotics inside the vehicle I called K9 Officer T. Caygle to assist me on the traffic stop. K9 Officer Caygle and his dog Havoc searched the vehicle. Havoc indicated on the black backpack Steve had said was his. Inside the backpack Officer Caygle located a glass meth pipe which he later turned over to me. See Officer Caygle's supplemental report for details.

Steve was arrested for his warrant, possession of methamphetamine, and possession of drug paraphernalia. Steve was booked into the WCCF without incident. See warrant information attached below. Kimberlee was given a verbal warning and released from the scene with her vehicle.

I placed the two meth pipes, the black pouch with baggies, and the two baggies with crystal into OPD evidence. Each of the baggies weighed .5 grams.

CONCLUSION

The suspect in this case was arrested on a warrant. Search incident to arrest police found methamphetamine and drug paraphernalia on his person. The suspect was booked on his warrant, possession of methamphetamine, and possession of drug paraphernalia.
