INSTRUCTION NO. 23  
defense of insanity  
insane at the time of the  
commission of each act if:

so diseased or defective in mind  
at the time  
incapable of distinguishing  
right from wrong

“incapable of distinguishing right from wrong,”  
as measured by a societal standard of  
morality,  
Instruction 23, does not refer to a purely personal and subjective standard of  
morality.

“incapable of distinguishing right from wrong,”

“does not refer to a purely personal and subjective standard of morality.”

Such as...

“Moral Relativism”

a condition of mind

caused by a mental disease or defect that prevented him from forming a culpable mental state

But care should be taken not to confuse mental disease or defect with moral obliquity,

But care should be taken not to confuse mental disease or defect with mental depravity, or passion growing out of anger, revenge, hatred, other motives

But care should be taken  
not to confuse mental disease or defect  
and kindred evil conditions  
when an act is induced by any  
of these causes,  
the person is accountable to the law.

“mental disease or defect”  
only those severely abnormal  
mental conditions that grossly  
and demonstrably impair  
a person’s perception or  
understanding of reality
